5. TEACHING METHODOLOGIES (INCLUDING EVALUATION)

The teaching strategies of the curricular unit were defined in order to promote an interactive learning, focused on the student, including active methodologies consistent with the objectives and expected results, based on research strategies, investigation, critical analysis and reflective thinking.

The assessment strategy includes the elaboration of a research project, based on the collection of relevant information; the selection of the most appropriate approach methodology as well as the different instruments or assessment strategies to be used in order to obtain credible results that answer the research questions posed.

The research project, to be submitted by July 19, is individual and will be evaluated on a scale of 0 to 20 points.

The success of this curricular unit requires a classification equal to or greater than 10 (ten) points in continuous assessment. There is no assessment by exam.

6. COHERENCE BETWEEN TEACHING METHODOLOGIES AND OBJECTIVES

The use of active methodologies, in which the teacher assumes the role of facilitator, learning guide and assessor of the acquisition of competencies by the student, and in which the student assumes the main responsibility for his/her own learning process, using research strategies, critical analysis and reflective thinking, allow students to acquire research competencies in accordance with the objectives set. To this end, students are expected to understand what characterises research and the different stages of its process.
